Persona Biography

We encourage all of you to think about where your Society persona comes from, and what their interests are. Allow your Chronicler to introduce your Lists Officer:

Meth ingen Magnusa Ruaith (Maeve daughter of Magnus the Red) is a medieval Irish lawgiver and judge. As a child she learned to read and write very early, and began making lists of everything she saw, and learned: spinning wheels, balls of thread, sheets in the cupboard, utensils in the kitchen, sheep and ducks on the green, children in the neighbourhood, and ladies on her father's visiting list. The lattermost consideration caused her father Magnus to encourage her further studies, and she spent many years absorbing all the intricacies of the Seanchas Már (Brehon Law). She continued to make lists thereafter; but only for the tourney field, on which she kept close watch on the local Fianna and ensured that their practice bouts were properly supervised.

Her most celebrated case thus far involved the plaintiff (Liam Óg Ó Cathain), who charged the defendant (Michéal Ó Raghallaigh) with theft of his wedding speech. Her judgment was acclaimed, following the famous precedent of St Calum and the Psalter he had copied from St Finian, who claimed Calum's work on the basis that the owner of a cow also owns whatever calves she may bring forth. Since the borrowed speech had already been uttered, she ordered that Michéal go in search of Liam's words and bring them back to him. Michéal returned a week later with his hands cupped, and in a simple yet moving ceremony bowed low before Liam's front door, and opened his hands. Honour thus satisfied, they resumed their former friendship.

Anachronism Corner

Yes, we are the Society for Creative Anachronisms. Occasionally your Chronicler likes to set the record wrong about a few historical matters. This month's Anachronism is brought to you by:

Hugh Morton

Hugh Morton is thought to be the father of the Burgundian composer Robert Morton. The latter worked for the Dukes of Burgundy, was a colleague of Hayne van Ghizeghem, composed a great many pieces of which only eight rondeaux survive, and produced the earliest setting we have of the piece *L'Homme Armée*, later used as a *cantus firmus* for masses written by everyone who was anyone at the time. Robert is reputed to have had no sense of humour at all, and it is conjectured that he spent his life attempting to live down his disreputable father.

Hugh was trained for the Church, and soon found himself booted out of the seminary owing to an indiscretion involving a small trebuchet, bread rolls, a tub of stewed beetroot and a visiting Bishop, who was unamused. He joined a travelling band of goliards (priestly songwriter-poets) and translated *Carmina Burana* into English. (The work was later burned by the public hangman.)



Hugh Morton and Willem van Ghizeghem in their unforgettable musical *The Assumption of the Virgin*. They were excommunicated as a result, but later pardoned after some formation grovelling to the Church, (qv) and by Duke Phillip's memorable quip: 'Oh, I don't know. That seems like a reasonable Assumption.'

Hugh was a gifted musician who specialised in the harp, and claimed to have invented reggae (which he called *rigge*: a Middle English word meaning 'back'). His innovative backbeat caught the ear of many at the time. Only the first verse of one of these songs now survives:

I was walking down the lane a long way from Suffolk
I heard a deep voice beside of me, look'd round with fear in my stomach.

I saw four faces: one mad, a brother from the hedgerow: They looked me in the eye And offer'd me a vegetable.

I say: I don't like turnips, oh no: I love them, (x2)

Don't you walk through my fields, ye've got to show some respect: Don't you walk through my barn and don't change the subject.

Later scholars have found fragments of the later verses which deal with Wat Tyler's rebellion, and adequately explain why the song was suppressed. Ordered to explain himself by an unimpressed Henry V, he confessed that

reggae was actually the work of bored cricketers in Hampshire who were waiting for the rain to stop. Hugh was supposed present at the Battle of Agincourt, and redeemed himself in the eyes of the Crown by composing the *Agincourt Carol*, commemorating Henry's startling victory over the French.

Hugh eventually settled in Burgundy, whose Dukes had traditionally been indulgent of his extravagances, and supposedly advised his son Robert: 'Steer clear of satire, son. It only gets you into trouble.'
